

# Principal's foreword

Kawana Waters State College is a co-educational Independent Public School that is an internationally focused Queensland Government State School. The college offers education from Prep to Year 12 on two adjacent campuses, separated by an environmental wetland area on the shores of Lake Kawana. The College is situated on the coastal strip between Mooloolaba and Caloundra on the picturesque Sunshine Coast, approximately 100km north of Brisbane. The College is set between the Pacific Ocean and the world class sports and rowing precincts of Sunshine Coast Stadium, Kawana Aquatics Centre and Lake Kawana. Directly across Lake Kawana, the College forms part of the vibrant and innovative health and business precinct including the Sunshine Coast University Hospitals. Close partners with this precinct, the University of the Sunshine Coast and the Department of Education International mean that academic pathways and international perspectives are abundant at Kawana Waters State College. The college strives to make this precinct the educational experience of choice for young people aged 5 to 18 globally. Kawana Waters State College is a Prep to Year 12 Independent Public School which means we have been granted a degree of autonomy to manage our own affairs subject to governance through a college council. Regular reviews and guality assurance processes against the National School Improvement Tool, Vocational education quality standards and International credentials occur. As a result, we enjoy a vibrant student program with opportunities for local students to travel and study overseas as well as welcoming international students to engage in a first class educational experience. Our curriculum embeds this international perspective. Local and international students also have the opportunity to apply for inclusion in our Programs of Excellence in Academic Curriculum Extension (ACE), Football, Aquatics and the Arts. Many students have gained State and National honours from these programs. Our College has a strong evidenced-based approach to Teaching and Learning, informed strongly by models of "High Reliability Schooling" and Marzano's "New Art and Science of Teaching". These approaches shape our students' everyday learning experiences around worldwide research in education, that has been informed and supported by the Sunshine Coast lifestyle and future employment options. We are student-centred, highly supportive College that is proud to be known as "Kawana's College". # Teacher standards and qualifications

The Teacher registration eligibility requirements: Policy (p.1) states:

To be eligible for registration, a person must satisfy the Queensland College of Teachers (QCT) that they meet requirements regarding qualification and experience, or have otherwise met the requirements of the *Australian Professional Standards for Teachers* (APST). A person must also satisfy the QCT that they are suitable to teach and meet English language proficiency requirements. All these requirements are specified in the Act and the *Education (Queensland College of Teachers) Regulation 2005* (the Regulation).

The qualifications required for teacher registration are successful completion of either -

- (a) a four-year initial teacher education program including teacher education studies of at least one year (e.g. a Bachelor of Education, or a double Bachelor degree in Science and Teaching) or
- (b) a one-year graduate initial teacher education program following a degree (e.g. a one-year Graduate Diploma of Education (Secondary) after a three-year Bachelor degree) or
- (c) another course of teacher education that the QCT is reasonably satisfied is the equivalent of (a) or (b). These are considered on a case-by-case basis.

The 2020 cohort was the first to complete Year 12 under the new senior assessment and tertiary entrance system. The new system has
redeveloped senior syllabuses, strengthened school-based assessment, introduced a common external assessment in each senior General
subject area and General (extension) and replaced the OP rank with the Australian Tertiary Admission Rank (ATAR). This represents a break in
time-series for the Queensland Certificate of Education.

2. ATARs are calculated by Queensland Tertiary Admissions Centre (QTAC). ATAR data is not held by the department.

3. Prior to 2020, visa students (students who are not Australian citizens or permanent residents of Australia) were excluded. From 2020 visa students are included.

## **Student destinations**

The Queensland Department of Education conducts <u>annual surveys</u> that capture information about the journey of early school leavers and Year 12 leavers from school to further study and employment.

### Early school leavers

Schools work closely with a range of external agencies to support students who left school early.

Our Principal, Deputy Principal, Regional Transitions Officer or Guidance Officer liaises with early school leavers and their parents, providing a service 'beyond the school gate' to assist early leavers make a successful transition to other educational pursuits or employment.
